NOTICE OF PUBLIC HEARINGS

NOTICE IS HEREBY GIVEN that the Moreno Valley City Council will conduct a Public Hearing during the regular meeting of the Moreno Valley City Council on Tuesday, March 1, 2022, at 6:00 p.m., in the City Council Chambers located at Moreno Valley City Hall, 14177 Frederick Street, Moreno Valley, CA 92552. The purpose of the hearing is to receive public input and testimony regarding possible revisions to Moreno Valley's city council electoral district plan.

Elections Code §§ 21600-21609 require the City to redraw its electoral boundaries every ten years, following the release of the Census. At the March 1st meeting the City's demographic consultant will present map options based on testimony received to date. All interested persons will be given an opportunity to comment on this item at the public hearing.

This is the third of four scheduled public hearings. The first two were held on February 1 and February 15. The final will be held in the City Council Chambers at the Moreno Valley City Hall, on March 15, 2022, at 6:00 p.m. The Council anticipates taking action to adopt adjusted council districts following the March 15 hearing.
