The purpose of the hearing to receive public input and testimony regarding possible revisions to Moreno Valley's city council electoral district plan.

Elections Code §§ 21600-21609 require the City to redraw its electoral boundaries every ten years, following the release of the Census. At the February 15th meeting the City's demographic consultant and special counsel will outline the redistricting process and seek public testimony regarding the districts and the City's communities of interest. All interested persons will be given an opportunity to comment on this item at the public hearing.

This is the second of four scheduled public hearings. The first was held on February 1. The other two hearings will be held in the City Council Chambers at the Moreno Valley City Hall, on the following dates and times:
