### NOTICE OF PUBLIC HEARING

**NOTICE IS HEREBY GIVEN** that the Moreno Valley City Council will conduct a Public Hearing during the regular meeting of the Moreno Valley City Council on Tuesday, April 5, 2022, at 6:00 p.m., in the City Council Chambers located at Moreno Valley City Hall, 14177 Frederick Street, Moreno Valley, CA 92552. The purpose of the public hearing is to receive public input and testimony regarding possible revisions to Moreno Valley's City Council electoral district plan.

Elections Code §§ 21600-21609 require the City to redraw its electoral district boundaries every ten years, following the release of the U.S. Census. At the April 5, 2022, public hearing, the City's demographic consultant will present updated map options based on testimony received to date. All interested persons will be given an opportunity to comment on this item at the public hearing.

This is the last of four scheduled public hearings. The first three were held on February 1, 2022, February 15, 2022, and March 1, 2022. The City Council anticipates taking action to adopt adjusted City Council districts following the closure of the April 5, 2022, public hearing.
